- **1. Attendance Confirmation.** Chair Anderson called the meeting to order at 3:36pm with a quorum of members present.

B. Website and Use of Members List. Secretary Sherbo has been asked to post on our website and use the section members list for various purposes – she wanted to receive guidance about what to post to the members list. Tommy Brooks suggested that 2x/month for an email blast to members would be a good rule of thumb limit. He noted that job postings and similar opportunities seems like good reasons to use the member list, or that we should delegate someone to make that decision. Better to get the word out for jobs than worry about bombardment of information on various listservs. RFP for legal services would be another good thing to advertise. Jim Brewer moved that all section directors/officers can determine whether to send something out via the members list. Seconded by Tommy Brooks. Motion passes unanimously. Secretary Sherbo will send this motion once finalized to the bar (Logan) so they know all directors/officers may approve content for the members list.
